The 2035 Strategic Plan is on the agenda of the February 25, 2025 meeting of the Board's Executive and Governance Committee and the March 18, 2025 meeting of the MTSU Board of Trustees.
3. [SACSCOC Reaffirmation](#) - Mary Hoffschwelle reminded everyone this is our year of record. We are on track documenting Differentiated Review compliance with 40 core requirements and standards. Our SACSCOC vice president will visit May 14-15 to meet with President McPhee and discuss our review progress.
4. [Quality Enhancement Plan](#) - Chandra Story discussed MTSU's next QEP topic, Career Readiness and asked committee members to think about how the potential goals align with what we are already doing. A QEP Town Hall has been scheduled for March 5, at 11 AM, in SCCM.
5. IEPR updates— Chris Brewer will convene a subcommittee to look at aspirational peers based on 2035 Strategic Plan elements. Farwell and Sutherland volunteered to serve. All are welcome. They will bring an update to the April meeting.
